



## **PARA-SCOPE<sup>(R)</sup> TERMS AND CONDITIONS**

**PLEASE READ THESE TERMS AND CONDITIONS (THE "AGREEMENT") CAREFULLY BEFORE USING THE SITE. THIS AGREEMENT APPLIES TO THE WEB SITE PARA-SCOPE.COM ("SITE") AND THE SERVICES PROVIDED THEREIN.
